<ul style="list-style-type: none"> <li>• Persons age 60 or older</li> <li>• The accompanying spouse of an eligible participant, regardless of age</li> <li>• Persons with disabilities who have not reached 60 years of age, but who reside in housing facilities occupied primarily by older persons at which congregate services are provided</li> <li>• Persons providing volunteer services during meal hours</li> <li>• Persons receiving home delivered meals are not eligible to receive a congregate meal on the same day</li> </ul>

<u>Client Eligibility for Title III Home Delivered Meals</u>	
<ul style="list-style-type: none"> <li>• Persons age 60 or older who are homebound because of illness or an incapacitating disability, or who are otherwise isolated;</li> <li>• The spouse of a person age 60 or older, regardless of age, if the receipt of the meal is in the best interest of the person age 60 or older; and</li> <li>• Persons less than 60 years old with disabilities who are members of the household of a person age 60 or older who is a Title III-C home delivered meal recipient.</li> <li>• Persons receiving a congregate meal are not eligible to receive home delivered meals on the same day.</li> </ul>
